About the Role:

We are seeking a caring, enthusiastic and reliable individual to join our team as an Afterschool Club Worker at our welcoming one-form entry primary school. You will be responsible for supporting the safe, engaging, and enjoyable running of our afterschool provision.

This role is initially for one afternoon per week (Mondays), but we are looking for someone who is flexible and willing to take on additional hours in the future to cover staff absences or increased demand.

Key Responsibilities:

- Supervise and engage children aged 4–11 in a variety of fun and age-appropriate activities.
- Create a safe, inclusive and stimulating environment for all children.
- Assist with setting up and packing away materials and resources before and after sessions.
- Build positive relationships with children, parents and staff.
- Ensure the health, safety and well-being of children at all times, following school safeguarding procedures.
- Provide simple snacks or refreshments as required.

- Experience working with or caring for children (in any setting).
- A kind, patient and proactive approach.
- Strong communication and teamwork skills.
- Ability to follow instructions and school policies, especially around safeguarding and health & safety.
- Flexibility to take on extra hours when needed.
- Clear, enhanced DBS check.

- First Aid or Food Hygiene qualification.
- Experience working in a school or childcare setting.
- Relevant childcare qualification
