
# **Extended Services Policy**

## **AIMS**

To ensure children are provided with a safe, secure and friendly environment in which they can enjoy a healthy, nutritious breakfast under the supervision of caring staff from 7.45am – 8.45am (Mon-Fri) and a snack from 3.30pm-5:45pm (Mon – Thurs).

# **OBJECTIVES**

- To provide a welcoming, safe, secure environment for pupil before the beginning of the school day from 7.45am to 8.50am and from 3.30pm to 5:45pm.
- To enable pupils to enjoy a healthy, nutritious breakfast before the start of the school day in a pleasant, relaxed atmosphere.
- To provide a calm play environment for pupils.
- To provide an affordable service to parents and carers.

## **PROCEDURES**

**Booking Arrangements** 

The Before and After School Clubs will open daily during term time but closed for INSET days and statutory holidays.

Sessions are to be attended in agreement with the school and should be pre-booked.

The charge per session for our Breakfast Club is £4.50 per child regardless of time of arrival.

The charge per session for our After-School Cub is £15 per child regardless of time of pick up.

Payment is via Arbor.

Childcare vouchers are also an acceptable method of payment.

Invoices will be sent at the end of every month and should be paid in full within 14 days of receipt.

Non-payment of fees may result in the withdrawal of the service to the parent/carer.

Extra sessions can be booked subject to availability – please contact the school office via the extended schools email address.

One term's notice will be given by school of any proposed variation in fees.

It is vital you inform us if your child is not attending a club, including illness, otherwise charges will be made for the cost of the sessions. Were possible, 24hrs notice is needed.

If you wish to cancel a session your child is booked in for, please let us know as soon as you can. Please note that refunds are only available for long term absence such as illness which last longer than six school days.

We understand that sometimes people run late, however if a child is picked up consistently late (3 or more instances) then a £5 surcharge will be added to the cost of each session when there is a late collection.

# **Registration and organisation**

An attendance register will be taken daily.

In case of an emergency where children have to be evacuated from the building, the register will be taken and children checked against it to ensure they are all present.

All staff will have enhanced DBS clearance.

The ratio of staff to children will not exceed 1:15.

The Club is open to all pupils of Meanwood CE Primary School from Reception to Year 6.

Sessions are held in the school hall or sometimes in the year 5 and 6 classrooms, depending on the use of the hall.

The maximum number of places available is capped at 40.

Children are encouraged to demonstrate good manners and adhere to our relational culture and behaviour policy.

Should behaviour continue to be a problem, the school reserves the right to withdraw the place at extended provision for the child either temporarily or permanently.

Breakfast will stop being served at 8.30am in order to allow sufficient time to clear away food and crockery.

At After-School club children will enjoy a healthy snack.

The children will then have the opportunity to join in any of the activities laid out in the hall – or outside weather dependent.

The child's details, medical conditions, parents/carers' contact details, an additional emergency contact name, address and telephone number are kept securely in school.

Parents are to bring their child/ren to the Green Road Entrance where communication can be made through the electronic door system.

## **Communications with Parents**

Verbal communication with parents/carers bringing children.

Text and email communication.

Parents/carers may make appointments with the Extended Provision Manager or Headteacher to discuss matters pertaining to either of the Clubs.

# **Medicines**

These will be administered in line with the school's Supporting Children with Medical Needs Policy

## **Personal Property**

Children should not bring in any electronic devices or other valuable personal property as we cannot accept responsibility for loss or damage to it, however it may have been caused.

# **Fire Precautions**

Children should exit out of one of the Green Road entrance and congregate under the litch gate.

A register will then be taken to ensure all children are present.
