		 If this occurs we will ensure that the child does not come into close contact with the dog. Dog kept clean and groomed. Dog is a Golden Doodle which is a (hypoallergenic) low/non moulting dog so this mean there is a very low chance of an allergic reaction to it. Dog bed kept in Headteachers office where flow of children is minimal and controlled. Office kept well ventilated. Dog bed and blankets to be kept clean and to a high standard.

Golden Doodles are bred to be sociable dogs and are often used as therapy dogs as they are known to be good with children.
